**Re: CCA s. 22 Notice and Extension No. 2 of Multi-Sector Service Accountability Agreement (“Extending Letter”)**

---

The *Connecting Care Act, 2019* (“CCA”) requires Ontario Health to notify a health service provider when Ontario Health proposes to enter into, or amend, a service accountability agreement with that health service provider.

Ontario Health hereby gives notice and advises Sioux Lookout Meno Ya Win Health Centre (the “HSP”) of Ontario Health’s proposal to amend the Multi-Sector Service Accountability Agreement (as described in the CCA) currently in effect between Ontario Health and the HSP (the “M-SAA”).

Subject to the HSP’s acceptance of this Extending Letter, the expiration date of the M-SAA will be extended from June 30, 2023 to September 30, 2023. All other terms and conditions of the M-SAA will remain in full force and effect.

Unless otherwise defined in this letter, all capitalized terms used in this letter have the meanings set out in the M-SAA.
